## **MAKING A COMPLAINT**

You can make a complaint in person or by:

- ◆ telephone 028 9049 1461 or fax 028 9049 1744;
- ◆ completing the form at the back of this leaflet;
- ◆ letter; or
- ◆ e-mail.

We will consider any special needs of a person making a complaint e.g. interpreter fees.

Our Professional Officer, Deirdre Vaughn will:

- ◆ follow up correspondence received and normally respond within five working days of receipt of your complaint;
- ◆ make a substantive response, where this is necessary, within one month. If this is not possible an explanation will be given for the delay;
- ◆ respect the confidentiality of all correspondence;
- ◆ ensure that all our correspondence is as informative as possible.
- ◆ investigate any complaints in a fair and independent manner whilst ensuring that the complainant does not suffer discrimination or retribution as a result of the complaint. Where appropriate, constructive action will be taken to avoid similar cause for complaint.
- ◆ provide the right of appeal directly to the Chief Officer if anyone is dissatisfied with how their complaint is handled.

## **OTHER CONTACTS**

If you are dissatisfied with how your complaint has been handled you can take your complaint to the Commissioner for Complaints, also known as the Ombudsman.

The Commissioner/Ombudsman is independent and can investigate complaints against government departments and other agencies, including the Commission. You can contact the Commissioner/Ombudsman at:
